RESOLUTION OF THE OGLALA SIOUX TRIBAL COUNCIL OF THE OGLALA SIOUX TRIBE TO AUTHORIZE AND APPROVE THE ACTING GENERAL MANAGER OF THE EAST WIND CASINO ROGER BRINGS HIM BACK TO ESTABLISH AN EAST WIND CASINO JACKPOT ACCOUNT AT FIRST NATIONAL BANK.

WHEREAS, the Oglala Sioux Tribe adopted its Constitution and By-Laws by referendum vote on December 14, 1935, in accordance with Section 16 of the Indian Reorganization Act of 1934 (25 U.S.C. § 5123) and under Article III of the Oglala Sioux Tribe Constitution, the Oglala Sioux Tribal Council is the governing body of the Oglala Sioux Tribe, and

WHEREAS, Article IV, Section 1(f) of the Constitution of the Oglala Sioux Tribe authorizes the Oglala Sioux Tribal Council to manage all economic affairs and enterprises of the Oglala Sioux Tribe, and

WHEREAS, pursuant to such authority, the Oglala Sioux Tribal Council established the East Wind Casino as an enterprise of the Tribe, and

WHEREAS, Roger Brings Him Back has served as the Acting General Manager of the East Wind Casino since January 1, 2022, following the retirement of the prior General Manager, and

WHEREAS, the Economic and Business Development Committee met on February 26, 2022, and recommends the Acting General Manager of the East Wind Casino Roger Brings Him Back establish an East Wind Casino jackpot account at First National Bank, and

WHEREAS, the Tribal Council finds that it is in the best interest of the Tribe and its members to accept the recommendation of the Economic and Business Development Committee; now


THEREFORE BE IT RESOLVED, that the Oglala Sioux Tribal Council hereby authorizes and approves the Acting General Manager of the East Wind Casino Roger Brings Him Back to establish an East Wind Casino jackpot account at First National Bank, and

BE IT FURTHER RESOLVED, that the Oglala Sioux Tribal Treasurer Mason Big Crow and East Wind Casino Roger Brings Him Back shall be the signatories on the new East Wind Casino jackpot account at First National Bank.
